Subject: - Reforms in distribution of food grains by Department of FCS&CA.

Government Order No. 14⁷ -FCS&CA of 2017
D a t e d: - 25 - 01 - 2017

To ensure transparency; proper implementation of e-PDS system; time bound delivery of PDS items-Rice/Atta to beneficiaries; stop pilferage of PDS commodities; Ensure timely availability; proper monitoring of release; transport and distribution of food grains by concerned authorities, it is hereby ordered as under :-

- a) The Director, FCS&CA Kashmir/Jammu shall start the process of procuring of food grains/lifting/transportation for the coming moth by or before 15th and complete the same by or before 30th of the current month so that food grains remain available at the FPS/sale depot on 1st of the next month positively. The sale of the food grains for any month shall start from 1st of the month and shall be completed by or before 10th of the month. This cycle shall start w.e.f February 2017 positively.
- b) SMS alert shall be given to 5-10 renowned persons/members of the Village Vigilance Committee about allocation/supply of food grains to the concerned FPS/Sale Depots of the village through an official specifically deployed for the purpose. Besides trucks dispatched/allotment information be also send through SMS to all concerned with information to Hon'ble Minister, FCS&CA , Secretary to Govt., FCS&CA Department & respective Director, FCS&CA.
- c) Food grains /other commodities be released only after the FPS shop owner clears previous liability(cost) and gives a statement clearly indicating the details about the quantum of food grains received in previous month; quantity distributed and balance quantity lying in centre.
- d) The Food Inspector of the area shall inspect 10-15 FPS Shops of his area during a month and submit his report regarding the distribution of the commodities in these shops. He shall submit his report to the District Level Officer/AD, FCS&CA concerned.

- e) The District Level Officers/AD, FCS&CA concerned shall have a cross check of at-least 10% of the shops checked by the Inspectors. He shall accordingly submit his report to the Director, FCS&CA.


