Subject:- **Constitution of Special Squads.**

Government Order No:- 30 -CAPD of 2015
D a t e d :- 13 .04.2015

Sanction is hereby accorded to the Constitution of Special Squads in all the Districts of Jammu and Kashmir State comprising of the following officers to conduct, monitor and supervise the functioning of the Auto Rickshaws, Taxis, Cabs and other service providers in this sector with regard to the installation/functioning of fare meters. The Special Squads shall work under the direct supervision of Deputy Inspector General of Police (Traffic) Jammu/Kashmir and shall submit the reports to the Government on fortnightly basis.

The Special Squads shall comprise of:-

1. Deputy Controller Enforcement Jammu/Kashmir (for Jammu and Srinagar Districts)
2. A.R.T.O. Concerned
3. Assistant Controller Legal Metrology (concerned)
4. Deputy Superintendent of Police, Traffic (concerned)
5. S.H.O (Concerned)

The Squads are authorized for making entries on the Route Permits of violators and after making three such entries the squads are authorized to cancel the Route Permits of the vehicles or any other action which the team may deem expedient to serve as a deterrent to the unfair practices being adopted by unscrupulous operators. Besides taking other necessary steps the squad shall ensure the display of Fair Charts to prevent the unnecessary fleecing.

The Special Squads shall also ensure that no Calibration Certificates/Fitness Certificates are issued to the operators plying without the installation of functional Fare meters.


