

The terms of reference for the committee is as under:-

1. The Committee shall work out the extra requirement of foodgrains including wheat/Rice and approach the Food Corporation of India for procurement of quantity at OMSS including participation of tendering as per terms and condition notified by the Food Corporation of India.
2. The Committee shall be responsible for lifting the entire grains for the procurement on or before 25th of the preceding month i.e 25th March, 2016 from the month of April, 2016 and so on.
3. The Chairman of the Committee shall ensure that effective liaisoning is maintained with Government of India and the Food Corporation of India and a team shall be deputed for a detailed meeting at New Delhi to get this arrangement in place.
4. The Committee shall also establish ways and means in which separate accounts and record is maintained for the NFSA allocation of foodgrains and also of additional quota sanctioned by State Administrative Council.



5. A weekly progress of work done and pending issues, if any, shall be communicated to the Administrative Department on every Friday.
6. The Committee shall be fully responsible for timely participation in bidding for procurement of ration at OMSS rates with Food Corporation of India and to also ensure timely offtake of the foodgrains, their transportation and follow all codal formalities and physical distribution with maintaining of proper records. Since, the initiative involves differential sales, therefore, separate storage is hereby ordered for different categories of grains and any lapse whatsoever on this account will be the personal responsibility of concerned official.
7. Committee shall be responsible for participation in Food Corporation of India tendering, ensure timely distribution, timely sales and remittance back to the Trading account so that the financial cycle is maintained.
