Sub:- Implementation of NFSA and duties of Joint Directors, Deputy Directors, Asstt Directors, Asstt. Directors and Chief Inspectors / TSOs / Area Inspectors of CA&PD with regard to monitoring of implementation of NFSA, checking proper categorization of households, issue of e-Ration Cards and Ration under NFSA and listening to complaints of Rationees etc.

Since J&K Govt. has implemented National Food Security Act from February 2016, it is imperative that field Officers are assigned the duties of monitoring of implementation of NFSA, checking Proper categorization of Households, issue of e- Ration Cards and Ration under NFSA and listening to complaints of Rationees, de-duplication of beneficiaries, de-weeding of bogus Ration Cards, for purification of data under NFSA..

It is therefore ordered that following Senior Officers / Officials of CA&PD will conduct tours/ inspections and physical checking of digitized data by holding camps at FPS level as under:-

| 1. Joint Directors CA&PD Directorates | 10% (at least 3 inspections in a week) |
| 2. Deputy Directors CA&PD Directorates | 15% (at least 4 inspection in a week) |
| 3. District Asstt. Director CA&PD. | 20% (at least 4 inspections in a week) |
| 4. Chief Inspectors of CA&PD | 25% (at least 2 inspections daily) |
| 5. TSO/ Area Inspectors of CA&PD | 30% (at least 2 inspections daily) |

It is further ordered that specific areas will be allotted by the concerned Directors to these Officers/Officials so as to attain 100% purification of digitized data. Directors, CA&PD will conduct 2% random checking to verify the authenticity of digitized data.

They will submit the weekly report after inspections/Camps held to the Administrative Deptt. through Directors.


